Legislation	LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976
	S 70 (1) 'a district council may charge such fees for the grant of vehicle and operators licences as may be resolved by them from time to time and as may be sufficient in the aggregate to cover in whole or in part
	(a) The reasonable cost of the carrying out by or on behalf of the district council of inspections of hackney carriages and private hire vehicles for the purpose of determining whether any such licence should be granted or renewed;
	(b) the reasonable cost of providing hackney carriage stands, and
	(c) any reasonable administrative or other costs in connection with the foregoing and with the control and supervision of hackney carriages and private hire vehicles.'
	Recent examples and legal opinion suggest that S.70 (1) does not allow ancillary charges (transfers/replacement licences/replacement plates/door signs) to be made during the term of the licence i.e after the grant. These costs may however be recovered as part of the grant fee itself
	Case law has established that pre-licensing requirements such as vehicle tests and hpi checks may be charged at a separate cost.
	S70 Fees for vehicle and operators' licences requires that if the fees exceed £25 that they must be advertised.
